#### **Bylaws Revisions**

The International Board of Directors has revised the Local Lodge Bylaws template to add two items of importance. See Articles VI and VII; these additions come from advice by counsel in order to help lodges protect themselves from a legal standpoint and to provide guidance in the unlikely event of a lodge dissolution. Below are the revised Wergeland Bylaws. Please see President Ramona's article for more information.

## Local Lodge Bylaws

#### Article I

- 1) The name of this lodge shall be: Wergeland, No. 28, Sons of Norway. La Crosse, WI District 5
- 2) Regular meetings shall be held at such time and place as the lodge itself shall determine. Special meetings may be called in accordance with the Charter, Constitution, Policies and Procedures of Sons of Norway.

#### Article II

#### Membership, Qualifications and Privileges

- 1) To become a member of Sons of Norway, the applicant must possess requirements outlined in the Constitution. Membership in the lodge is effective immediately upon ONE of the following (check one):
  - payment of dues; or
    - affirmative vote of the Lodge.
- 2) The membership shall consist of financial benefit members and social or non-benefit members either of whom may be Life, Golden, Family, Juvenile, Heritage, Unge Venner or Honorary members in accordance with the Constitution.
- 3) Life membership shall be extended to all members who were 65 years of age or older, and who had been members in good standing in the Society for 30 years or more by Jan. 1, 1999. Years of membership need not be consecutive. Life membership shall be extended to any member who has served as President of the International Lodge.
- 4) Golden membership shall be extended to all members who attained 65 years of age after Jan. 1, 1999, and who have been members in good standing in the Society for 30 years or more. Years of membership need not be consecutive.
- 5) In all respects, Life or Golden members shall enjoy all rights and benefits they previously held in the lodge as full dues paying members. Those transferring to another Local Lodge shall maintain their Life or Golden membership status.
- 6) All members shall enjoy equal privileges, except that only financial benefit members shall have the right to vote on matters concerning financial benefits.
- 7) Affiliate Membership. Members possessing a current membership card of a different lodge may petition for affiliate membership. Affiliate members may not vote within the lodge for, or become, District or International convention delegates from this lodge and are not counted in the member totals for determining representation.

#### Article III

#### Fees and Dues

- 1) The International Lodge sets the dues rate for all lodges in the order. All lodges are subject to an identical dues structure within their respective countries. A member's dues will be divided into three parts one part to International, one part to the District, and one part to the Local Lodge. Only a vote by the International Lodge can change the dues amount.
- 2) The International Lodge sets the dues rate in the local currency (US or Canadian dollars or Norwegian Kroner). Sons of Norway headquarters will not adjust dues based on the exchange rate. Dues paid by credit card from a non-US bank may be subject to an exchange rate and/or servicing fee set by the bank and/or credit card processor.
- 3) In the unlikely event that a Local Lodge does not need its share of the dues collected, it is allowed to refund the local dues income to its paying members.
- 4) Life members are exempt from all dues International, District, and Local.
- 5) Members of United States lodges who achieved Golden status before January 1, 2018 pay 50 percent of International dues and 100 percent of District dues. U.S. members who achieved Golden status after December 31, 2017 will not receive a discounted dues rate.
- 6) Members of Canadian and Norwegian lodges who achieved Golden status before January 1, 2020 pay 50 percent of International dues and 100 percent of District dues. Canadian and Norwegian members who achieved Golden status after December 31, 2019 will not receive a discounted dues rate.
- 7) Affiliate members. In addition to their primary lodge, some members may wish to join another Local Lodge. Such membership is

## Sons of Norway Mission Statement

The mission of Sons of Norway is to promote and to preserve the heritage and culture of Norway, to celebrate our relationship with other Nordic Countries, and provide quality insurance and financial products to our members. considered an affiliate membership. For each additional lodge joined, the affiliate member will be charged only the Local Lodge portion of dues.

- 8) Members of U.S. Lodges will have the option to pay their dues by automatic monthly withdrawal from their U.S. bank account.
- 9) No fee shall be charged to issue a transfer card or to transfer membership.
- 10) Heritage members (under age 16) will be exempt from dues.

#### Article IV

#### Good Standing

- 1) A member who is in arrears 120 days in the payment of dues shall not be eligible for any benefits of the lodge and will be subject to suspension in accordance with the procedures set forth in the Constitution.
- 2) A member who pays all back dues will be reinstated effective with their original date of membership.

#### Article V

#### Lodge Funds

- 1) Appropriations to defray the operational expenses of the lodge require only a simple majority vote for adoption. Other appropriations from the lodge funds require a two-thirds majority of votes cast for adoption.
- 2) The lodge can maintain one or more funds. The general fund will be used to defray the operational expenses of the lodge.
- 3) The financial officers of the lodge are covered by a blanket position bond, as provided in the Constitution, with a deductible for each claim. A surety bond is maintained by International Headquarters, in accordance with the Constitution.
- 4) The Local Lodge elects (choose one)
  - □ to retain the positions of Financial Secretary and Treasurer with duties as described in the relevant sections of the Charter and Constitutions of Sons of Norway, or
    - It to have a Membership Secretary and a Treasurer with duties as described in the relevant sections of the Charter and Constitutions of Sons of Norway.
- 5) The lodge shall participate in the mandatory liability insurance for District and Local Lodges as secured by the International Headquarters. This insurance does not cover lodge-owned real estate or buildings, or liquor liability claims.

#### Article VI

#### Compliance

- 1) The lodge must operate in full compliance with all governmental laws, regulations and applicable requirements and maintain in force all licenses, permits and approvals required for its operation.
- 2) The lodge must operate in full compliance with all laws, regulations and applicable requirements as outlined in the latest edition of the Charter, Constitutions, Policies and Procedures of Sons of Norway, and as otherwise communicated to the lodge by the International Headquarters of Sons of Norway. These include, but are not limited to, the timely annual filing of IRS 990 forms, the D63 and D17 reports for lodges, the D64 and D18 reports for building corporations, if applicable, and the timely payment of the Local Lodge liability insurance assessment.

#### Article VII

#### **Dissolution and Distribution of Assets**

- 1) Dissolution, either voluntary or involuntary, shall be made only in accordance with the procedures as set forth in the Sons of Norway Charter, Constitutions, Policies and Procedures.
- 2) In the event of dissolution of the lodge corporation(s), both lodge and building association, if applicable, it is recommended that the corporation's remaining assets shall be distributed to the Sons of Norway Foundation [an IRC 501(c)(3) organization], if in existence when the distribution occurs or, if not, to a like designated and purposed entity or entities.
- 3) Upon dissolution of the lodge, lodge assets may not be transferred to individual members for personal benefit.
- 4) The plan to distribute lodge assets must be approved in advance by Sons of Norway Headquarters. However, Headquarters shall not oppose any plan of distribution that complies with relevant state and federal laws and regulations.

#### Article VIII

#### Changes in and Approval of Bylaws

- 1) These bylaws may be repealed or amended by a two-thirds majority vote of the members present and voting, provided that such bylaw changes were presented in writing and read at the prior meeting of the lodge.
- 2) These bylaws, and any changes thereto, will become effective upon approval by the International Headquarters.
- 3) The bylaws of this lodge are subject to the terms and conditions contained in the Charter and Constitution of the International Lodge of Sons of Norway.

# A little in English...

#### **The Young Flame**

Rikard Nordraak, together with the poet Bjørnstjerne Bjørnson, is responsible for all of us clearing our throats and belting out "and the saga night that lays, lays dreams upon our earth."

Nordraak was born on June 12, 1842 in Christiania. His family has a piano in the living room, and Rikard starts playing early. In 1850, his cousin Bjørnstjerne Bjørnson, who is in town to study, moves in with his family. Bjørnson observes that the young boy has musical talent.

#### Yes, We Love «Ja, Vi Elsker»

"Ja, Vi Elsker" extends over an abnormally wide tonal range to be a sing-along. It is overambitious. Many have probably experienced starting as deeply as they can, and still ending up with a squeaky voice at the end of the song. The lyrics are written by Bjørnstjerne Bjørnson. When the poem is to be set to music for the Constitutional Jubilee in 1864, Bjørnson of course gives the assignment to his dear cousin.

The first official performance takes place at the constitutional jubilee, May 17, 1864. The men's choir conductor recounted about the first rehearsal that the song "was immediately beloved and that everyone felt: 'Now, this is our national anthem!'"

The timing is perfect. As Bjørnson says, "Ja, Vi Elsker" inhales the breath of an entire people, a few decades prior to Norway becoming independent.

"Ja, Vi Elsker" quickly becomes the national anthem by virtue of its popularity. At 21 years old, Rikard Nordraak has managed something incredible.

#### On his deathbed

In November 1865 Nordraak contracts pneumonia. After five months of illness, surrounded by doctors and his landlord, Rikard Nordraak dies on March 20, 1866.

Although we can later read all the praise about Nordraak, his funeral goes unnoticed, and is a testament to a lonely young man. Two people show up at the funeral procession: his landlord and a friend.

#### New relevance

Beyond the 20th century, Nordraak's ideas gained new relevance when Norway became independent. He is honored with memorials in Berlin, Copenhagen and Oslo, before his urn is moved to The Cemetery of Our Saviour in Oslo in 1925.

In December 2019, "Ja, Vi Elsker" was officially voted Norway's national anthem by the Storting, after having been in use for over 150 years.

## Lítt på Rorsk...

#### Den unge flammen

Rikard Nordraak er saman med diktaren Bjørnstjerne Bjørnson ansvarleg for at vi alle reinskar halsen og tar sats ved «og den saganatt som senker, senker drømme på vår jord».

Nordraak blir fødd 12. juni 1842 i Christiania. Familien hans har piano i stova, og Rikard byrjar å spele tidleg.

I 1850 flyttar søskenbarnet Bjørnstjerne Bjørnson, som er i byen for å studere, inn hos familien. Bjørnson observerer at den unge guten har musikalsk talent.

#### Ja, vi elskar «Ja, vi elsker»

«Ja, vi elsker» strekk seg over eit unormalt langt tonesprang til å vere allsong. Han er overambisiøs. Mange har nok opplevd å starte så mørkt dei kan, men likevel ende opp med pipestemme ved slutten av songen.

Teksten er skriven av Bjørnstjerne Bjørnson.

Då diktet skal bli tonesett til Grunnlovsjubileet i 1864, gir Bjørnson sjølvsagt oppdraget til sin kjære fetter.

Første offisielle framføring blir under Grunnlovsjubileet 17. mai 1864.

Dirigenten til mannskor har fortalt om den første øvinga at songen «elskedes straks og alle følte: her er vår nasjonalsang kommet!»

Tidspunktet er perfekt. Som Bjørnson seier, tar «Ja, vi elsker» opp i seg pusten til eit heilt folk, nokre tiår før Noreg blir sjølvstendig.

«Ja, vi elsker» blir ganske raskt nasjonalsongen i kraft av sin popularitet. 21 år gammal har Rikard Nordraak klart det utrulege.

#### Dødsleiet

l november 1865 får han lungebetennelse. Etter fem månader med sjukdom, omgitt av legar og husverten, døyr Rikard Nordraak 20. mars 1866.

Sjølv om vi i ettertid kan lese alle godorda om Nordraak, glir gravferda hans umerka hen, og vitnar om ein einsam ung mann. To menneske møter opp i gravferda: Husverten og ein ven.

#### Ny Aktualitet

Utover 1900-talet får Nordraaks idear ny aktualitet når Noreg blir sjølvstendig. Han blir heidra med minnesmerke i Berlin, København og Oslo, før urna hans blir flytta til Vår Frelsers Gravlund i 1925.
