#### **Cindy Olson**

Cindy gave a history of the Sons of Norway Foundation, which is 46 years old. She explained it is an endowment foundation-- they spend only a certain percentage of their assets on scholarships and grants. The Board of Governors, established in 2011, are responsible for: establishing scholarship and grant guidelines; awarding grants and scholarships; fundraising to meet the needs of the Foundation; for financial investments and administration of Foundation funds; and setting policy. The Director of the Sons of Norway Foundation is a paid staff position. The Director works with the Board of Governors and is responsible to the CEO.

The Foundation's passion is creating opportunities for higher education as a means for success, showcasing our unique Norwegian heritage to wider audiences, exploring cross cultural exchanges, and providing humanitarian support to Sons of Norway members who are victims of natural disasters.

The Foundation annual averages are: Awards: between \$70,000-\$80,000; Draxten Fund camperships between \$8,000-\$10,000; Grants average between \$25,000 and \$35,000. Legacy gift donors give gifts of \$5,000 or more and they have been responsible for 85% of our Foundation assets. Donors with gifts of \$100,000 or more may establish scholarships or grants in their name.

She reviewed the Foundation support to District 5.

#### Ken Thul

"Committed to you-- what's in a name"? Ken introduced the Fraternal Benefit Counselors who were in attendance-- Orion Carlson, Greg Ragan and Jay Erickson. His presentation discussed the stability, strength and society Sons of Norway has. Sons of Norway focuses on three core business areas: Fraternal, Financial and Foundation. Each year the profit contribution from insurance operations are used to help offset the cost of publishing the *Viking* magazine and to support the cultural and heritage programs. In 2011, over \$1.2 million was given.

#### **Folk Art Competition**

Owen Christianson encouraged people to view the exhibits today and Saturday. Anyone with exhibits will need to remove their entries on Saturday. There were 49 entries in the competition and 11 in the exhibition area. Jean Bittner, Nancy Kittleson and Elspeth Christianson served as judges. He also explained the People's Choice voting process.

#### Joe Annotti

Joe is the President and CEO of American Fraternal Alliance (AFA). They represent 70 benefit societies across the country. They are a trade association which represents their members in advocacy, education and information. They engage with regulators and lawmakers on a federal and state level to represent the needs of their members. They offer all types of education for their members and others involved in Fraternal management. They offer a lot of information electronically on **www.fraternalalliance.org**. He explained what Sons of Norway does, reflects on others involved in Fraternal benefits.

He stressed solvency, relevancy and governance are critical to the success of Fraternals. Governance structure needs to be addressed in order for Fraternals to solve many of the other problems. Governance is the process of decision-making in an organization. The old fraternal model is based on the convention decision-making process who meet on a regular basis. Some still elect their CEO at these conventions and debate their salaries! We live in a democratic republic-- not a democracy-- and Fraternals can't survive on a purely democratic process. The members sole job needs to be elect a qualified Board of Directors who will make the decisions, hire a CEO, and have the CEO hire staff and manage the organization. He strongly urged the delegates to keep that in mind as we do the business of Sons of Norway. He quoted an author who states great companies must be profitable, be around for a long time (endurance), and answer the question- if they were gone, would they be missed? Who would fill that void? We need to be effective on the local level.

Joe answered questions from the delegates. He explained the importance of collecting volunteer hours because they report to Congress. Congress views tax exemptions as a loss of revenue so it is important to report the volunteer hours. Congress puts a value on the volunteer hours (over \$20/hour), and last year, the AFA reported 92 million hours of volunteer work valued at \$1.4 billion dollars.

#### **Cindy Olson**

Cindy gave a presentation on "The Sons of Norway Message.". She reviewed the Sons of Norway Mission and the ways members can help achieve it. Without the support of the insurance component, our dues would be over \$120/member. Sons of Norway has over \$325,000,000 in total assets. Current Norway is just as cool as the Norway of the past-- she talked about their environmental concerns, architecture, and other advancements, achievements and involvement their county has. She encouraged members to look to the future and support their lodge, the financial benefit portion of the organization, and becoming an organization of events and not just meetings. She encouraged the members to visit the Sons of Norway Website and to click on every part of it to learn all about the great things on it!

#### **Coffee Breaks**

President Bennett acknowledged Zone 1 lodges who sponsored the morning coffee break.

#### **Credentials Committee**

Thomas Maxson reported on the Credentials Committee. Their review of the delegates match the 130 who Secretary Arneson called at the start of the session. There was a motion to seat the delegates, 2nd and the motion passed.

#### 2010 Minutes

Secretary Darlene Arneson presented the 2010 minutes which had been sent to all 2010 delegates and posted on the District 5 Website. The minutes were approved as presented.

#### The Rules for the 2012 District Lodge meeting were approved as presented.

- 1. The Regular meeting of District Lodge Five shall be one meeting, recessing from session to session within the meeting.
- 2. Delegate badges and voting materials will be issued at the Registration Desk upon presentation of some form of ID.
- 3. Delegates shall be seated in their seats at least <u>5</u> minutes before the scheduled time. Doors will be closed when each session begins. Persons awaiting admission will be at the direction of the Chair.
- 4. Any Delegate may speak to any subject before the Lodge. Any Delegate who desires to speak shall address the Chair by going to the microphone, with identification paddle raised, and state name and local lodge.
- 5. Each speaker will be allowed <u>THREE MINUTES</u>. No Delegate shall speak to the motion more than twice, unless allowed by the Chair. No delegate will be allowed to speak the second time until delegates stationed at the microphones have spoken.
- 6. The right to raise a Point of Order shall be reserved for Delegates only; the Chair will decide its validity.
- 7. If the previous Question is moved and carried, Delegates who are in line at the microphone at the time the motion is passed will be permitted to speak.
- 8. Only duly authorized seated delegates may vote **ONE** vote per delegate.
- 9. Ballots shall be used in cases where there are two or more candidates for any office, otherwise election shall be by acclamation.
- 10. Any messages to Delegates shall be relayed through Greeters, Marshall or Assistant Marshall.
- 11. No smoking shall be permitted.
- 12. Any Lodge bidding to host the next District Convention shall present its bid, in writing, to the District Board of Directors prior to the District Lodge Meeting. The bids shall be referred to the Committee on Reports which shall present all bids received at the first session of the District Lodge. Representatives of the bidding local lodges or District Lodge shall immediately thereafter be permitted <u>TEN</u> minutes to present their proposal. The vote on Convention site selection shall take place at the last session of the District Lodge.
- 13. Any resolution or by-law which has financial impact must be introduced by 10:00 am Friday so that such resolution or by-law may be reviewed by the Finance Committee to determine the financial impact. The Finance Committee shall present an impact statement to the Delegates.

President Mary Bennett listed six goals for the past two years-- two were achieved and four were not. The two successful goals were expanded: financial benefit participation, and each Lodge participated in one zone activity.

Vice President Burt Bittner reported five Lodges had an increase in their adult members, but most Lodges had slight increases. If you need to increase your membership, - talk to Myrmarken, Mandt, Gjemtedal, Nordlyset and Tre Elver.

Secretary Darlene Arneson thanked webmaster George Sievers for maintaining a Website which serves all lodges and Duane Kittleson for helping with everything. All Lodges need to share ideas and programs.

Treasurer Duane Kittleson converted bookkeeping records to QuickBooks computer software program. The District Board continues to be very frugal and manages the treasury very well. The Lodge ended the year with a \$9,637 increase to the cash reserves.

Dave Hermundson, District Recreation Director, said *Barnebirkie* and the *Birkebeiner*- continue to be very popular and gives Sons of Norway good publicity. Fifth District bowling and golf events are also well-liked. The Sons of Norway Sports Medal program is still in transition, but one of its goals is for every Lodge to earn at least one sports medal each year.

Gary Melby announced the position of the *Viking* Correspondent will be combined with the office of the Fifth District Publicity Director. So, from now on, send pictures for the *Viking* magazine to the Publicity Director. He also announced that the Ole Bull News is now on the Fifth District Website.

Cultural Director Owen Christianson has finished building his Viking Longhouse and has given many talks about it and his "Eat like a Viking" report. SON headquarters is presenting revising cultural skills, making them easier to document and finish.

Youth Director Don Hermanson has posted forms needed for youth activities on the District 5 Website (www.sonsofnorway5.com). Many campers attending *Masse Moro* now come from outside District 5 because it has become so popular. *Masse Moro* has acquired new language tools for camp as well as improvements to the kitchen, main cabin, and now the Beaver Creek Reserve is renovating the shower house. Camper safety is still the district's paramount concern.

Diane Overby announced pictures which do not make the *Viking* magazine are displayed in albums at the Barnebirkie table.

The committee wished to thank all the Officers for their time and work for the Sons of Norway organization.

There was a correction to the Vice President's report which highlighted the lodges which had shown increases. The list should be: Viking, Solvang, Ostestaden, Mandt, Nordlyset, Tre Elver, Artic Circle and Music City Vikings who all had increases in membership.

There was a second to approve the report. The report was approved. The committee was excused.

#### **District 5 Proposed By-laws**

**By-Law Change #1:** District Five By-Laws (Requires a 2/3 vote)

Affects: Article VII, Paragraph 1,3, 7

WHEREAS: There have been changes in the distribution of the Ole Bull publication;

WHEREAS: All other Districts have one position who is responsible for Viking photo submission and other

publicity;

WHEREAS: A Publicity Director can streamline efforts by working closely with our Webmaster;

THEREFORE BE IT RESOLVED: The position of the *Viking* Correspondent be eliminated and all duties associated with it be transferred to the Publicity Director.

#### **ARTICLE VII...OFFICERS AND SALARIES**

Par. 1 The elected Officers of the District shall be: President, Vice-President, Secretary, Treasurer, Recreation Director, Publicity Director, <u>Viking Correspondent</u>, Cultural Director, Youth Director and the General Directors provided for in these By-Laws.

Par. 3. The President, Vice President, Secretary, Treasurer, Recreation Director, Publicity Director, Viking Correspondent, Cultural Director and Youth Director shall be nominated and elected in that order, after which each Zone shall hold an election caucus and nominate the number of Directors and Alternates to which they are entitled as provided for in these By-Laws. Par. 7 The President, Vice President, Secretary, Treasurer and Publicity Director and Viking Correspondent shall receive such compensation as determined by the District Lodge. The Board of Directors shall make recommendations to each District Lodge Meeting with respect thereto.

Be sure to include the youth when it is time to give out the membership service pins.

<u>Promotion/Publcitity</u> – When you have the opportunity to promote your lodge by participating in a festival, parade or special event, take advantage of it. Whether it be having a booth at a festival or working in a booth for a special event, like the lola Car Show, DO IT!

<u>Delegate</u> – When working on special lodge events like *Syttende Mai* or *Julefest* for example, break down the tasks and ask lodge members to help. This process will help newer members get involved with the lodge and the other members.

<u>Resources</u> – Make sure all of your lodge board members are aware of information available on the Sons of Norway Website. The Media Library is especially helpful in planning lodge programs.

<u>Member Retention</u> – We strongly suggest two and three year payment plans for membership be instituted. If a member wished to pay for two years, they could have a \$5.00 discount, and for a three-year payment a \$10.00 discount.
