Thomas Maxson, Credential Committee Chair, reported that all delegates were in good standing and had been properly elected by their lodges.

The 2014 District Lodge Five meeting rules were presented.

- 1. The Regular meeting of District Lodge Five shall be one meeting, recessing from session to session within the meeting.
- 2. Delegate badges and voting materials will be issued at the Registration Desk upon presentation of some form of ID.
- Delegates shall be seated in their seats at least <u>FIVE</u> minutes before the scheduled time.
 Doors will be closed when each session begins. Persons awaiting admission will be at the direction of the Chair.
- 4. Any Delegate may speak to any subject before the Lodge. Any Delegate who desires to speak shall address the Chair by going to the microphone, with identification paddle raised, and state name and local lodge.
- 5. Each speaker will be allowed <u>THREE MINUTES</u>. No Delegate shall speak to the motion more than twice, unless allowed by the Chair. No delegate will be allowed to speak the second time until delegates stationed at the microphones have spoken.
- 6. The right to raise a Point of Order shall be reserved for Delegates **ONLY**; the Chair will decide its validity.
- 7. If the previous Question is moved and carried, Delegates who are in line at the microphone at the time the motion is passed will be permitted to speak.
- 8. Only duly authorized seated delegates may vote **ONE** vote per delegate.
- 9. Ballots shall be used in cases where there are two or more candidates for any office, otherwise election shall be by acclamation.
- 10. Any messages to Delegates shall be relayed through Greeters, Marshall or Assistant Marshall.
- 11. No smoking shall be permitted.
- 12. Any Lodge bidding to host the next District Convention shall present its bid, in writing, to the District Board of Directors prior to the District Lodge Meeting. The bids shall be referred to the Committee on Reports which shall present all bids received at the first session of the District

Lodge. Representatives of the bidding local lodges or District Lodge shall immediately thereafter be permitted <u>TEN</u> minutes to present their proposal. The vote on Convention site selection shall take place at the last session of the District Lodge.

13. Any resolution or by-law which has financial impact must be introduced by 12:00 PM Friday so that such resolution or by-law may be reviewed by the Finance Committee to determine the financial impact. The Finance Committee shall present an impact statement to the Delegates.

There was a motion to approve the 2014 meeting rule. 2nd. Motion passed.

Nominations Committee: Tom Boudreau (Chair), Mary Bennett and Duane Kittleson announced their progress on securing nominees for the District Board. President-Owen Christianson (Zone 2); Vice President-Diane Hesseltvan-Dinter (Zone 4); Secretary-Darlene Arneson; Treasurer- Adrian Johnson (Zone 2); Recreation-Andrew Johnsen (Zone 6); Publicity-Joy Bashara (Zone 4); Cultural-Esther Charlton (Zone 6); Youth-Cheryl Schlesser (Zone 3); This leaves: Zone 1--need one; Zone 2-none; Zone 3-need one; Zone 4-none; Zone 5-need two; Zone 6-none; and International Director-Jon Grinde.

There was discussion about proposed changes in the nominating committee and nomination process. A Question of Parliamentary Inquiry was called for. There was a break when the President conferred with Parliamentarian Royce DeBow. President Hermanson asked for nominations for any of the vacant offices.

The meeting recessed for lunch.

President Hermanson called the meeting back to order. Delegates #47 (Sarah Hoffman- Vakkertland 570) and #78 (Barbara Drew- Leif Erikson 097) are present for a total of 122 delegates.

There were no officer nominations from the floor. The election nominating from the floor was closed.

Chairman Iverson recommended that delegates read Treasurer Kittleson's comments on page 21 of the Reports Book. The committee met on June 26 and referred to pages 39-43. We see that when the memberships go down less money is sent to the Lodges from the International Headquarters "District Fraternal Program Fund". We feel it would benefit Lodges to have emphasis on membership drives. We feel one of the biggest concern is on the unreimbursed costs back to the District Lodge. Members are not participating in Fraternal events so encourage members to sign up for Fraternal actives such as bowling, golfing etc. It would benefit the Lodges to promote interest in giving contributions, donations, memorials and private scholarships for Masse Moro and youth scholarships. We feel that District 5 would benefit with some new fund raising ideas. This could help raise the yearly totals which were down \$557.40 from last year.

With concerns for Resolution#1 (Officer Compensation found on page 30). We support the resolution as it would save us approximately \$5,700.00 per year. Looking at the Treasurer' report on page 21 we are already down \$5,010.00.

With concerns to Resolution#2 (Delegates Expense page 30), the committee recommends supporting the resolution as it would save District 5 money.

Report of the Reports/Publicity Committee

President Hermanson welcomed everyone to our convention which marks the 200th anniversary of the signing of the Norwegian Constitution and also the 100th anniversary of our own district. We are all encouraged to meet as many delegates and district members as possible to share information about lodge activities and recruitment ideas. Everyone is looking forward to the "Bunad" show which is new for this year. It is the hope of President Hermanson that everyone will leave refreshed and reinvigorated about the Sons of Norway.

Vice-President Baldukas wants us all to be concerned with recruitment and retention in our lodges. One major point is that lodges should never combine monthly and board meetings. He also stated that meetings should never be spent arguing about details. He suggested that there are many valuable tips on the District 5 website.

Secretary Arneson feels we all should take more advantage of resources available such as our International Office, Board of Directors and our Financial Benefits Counselors. Secretary Arneson would also like to thank George Sievers for all of his work on our website and to all those board members who are stepping down.

Treasurer Duane Kittleson states that our balance is slightly decreasing, but offers a couple of ways to rectify that situation. An increase in membership would improve our financial position as would new ideas for fundraising.

District Recreation Director Andy Johnson reported that the Barnebirkie was still very popular. The Fifth District Bowling Tournament was also a big hit. He hopes that everyone will participate in the Walk-A-Thon which supports the Masse Moro Youth Camp.

District Publicity Director Gary Melby thanked everyone for sending in their photos and stated that we are saving a lot on printing costs by having Ole Bull News on our website, rather than in print.

Our District Cultural Director Owen Christianson's term will also expire. Owen created several programs during his term that are thriving and hopefully will continue to do so. Changes to the Folk Art Competition and a medalist program are new this year.

District Youth Director Mary Bennett stated that we have a wonderful scholarship program, and the "Shining Star" of District 5 is the Masse Moro Youth Camp. Finally, she wanted to thank Mandt 314, Nordland 544 and Norseman of Lakes 650 for hosting the convention.

More direction and instructions to the convention committees would be helpful. Repeat appointment to the same committee would also be helpful in giving committees guidance and direction.

In conclusion, the committee would like to see in the directors' reports a little better explanation of what has happened over the last 2 years and what we are striving for in the next 2 years. We should strive for the positive aspects of the District 5 and the Sons of Norway and what we have to offer. - Resolved, That By-Laws **ARTICLE III...MEETINGS AND REPRESENTATION** be amended as follows:
- Par. 3 Members of Central Lodge #50005-000 shall be entitled to two representatives for the lodge, and one representative for every 100 members or major fraction thereof, based on the last Semi-Annual Report prior to the election of delegates. All members in good standing are eligible representationas representatives. Members wishing to be candidates as delegates to the District Lodge meeting should notify the District President of their desire no later than February 1 of the convention year. Those so notifying the District President need not be present, though attendance is encouraged, at the Central Lodge meeting held to elect lodge delegates.
- Par. 4 The Central Lodge will meet at the call of the District President. Unless the President calls a special meeting, the lodge will meet at the time and place as indicated each convention year in the January issue of *Viking* magazine; and the biannual meeting is for the purpose of electing delegates to attend the District Lodge meeting. The District President has the option to call the meeting with members participating via electronic means, such as telephone or Skype.
 - Subpar. a The electronic meeting means must accommodate reasonable identification methods, such as available by telephone or Skype. Participation via e-mail is not acceptable.
 - Subpar. b Those participating by electronic means must identify themselves, upon entering the meeting and when voting, by giving their full name and membership number.
 - Subpar. c The District Secretary will call roll for attendance and for each vote with all members participating by electronic means using the method in Subpar. b, above, for each response.
 - Subpar. d The District Board of Directors will approve minutes of the Central Lodge meeting at the next District Board of Directors meeting and include those minutes as part of the District Board of Director meeting minutes.

Par. 4Par. 5 The Board of Directors of District Lodge Five shall determine the duration of the District Lodge meeting.

As defined by President Hermanson, the fraternal affairs committee discussed many facets of the Sons of Norway organization with the exception of financial and Foundation matters. - Increase the photo space in the *Viking* magazine to showcase more lodge events.
