# **Update on Financial forms:**

D-17 Audit form for lodges and building corporations: I have had a number of email exchanges with the International office as the new forms are not on the website and the mailing has not been sent to the lodge treasurers yet. I know there is a lot going on for this year-end at the office with year end finances, membership, new dues structure.....

I was told on Wednesday night that the forms will be done "soon" and the mailing will go out to treasurers. I was also told that there will be a revised form for building corporations.

I am not sure when they will be done. Mandt was to have our audit last night but it was cancelled due to icy roads. I hope we have this all early next week.

# This Year-End Report mailing contained three documents. All are due February 1, 2018!! This was sent to the lodge secretary and Mandt's was postmarked November 14. If you have a new secretary, they need to get it from the previous secretary!

- American Fraternal Alliance Year End Report- one page and if you enter the hours online at FraternalGives.org, you don't need to fill out the form.
- Lodge Achievement Form- this is a REQUIRED REPORT. Due February 1, 2018.
- Family Lode of the Year- not required but I highly recommend you fill it out. Due February 1, 2018 and needs to be signed by the Lodge President and Secretary.

Also due in February, the D17 Lodge Audit Report! I don't have a copy of this one so am not sure of the instructions. It will be sent to the lodge treasurer. If you own a building, both the lodge and the building corporation must fill these out and I was informed that the building corporation D17 form will be revised and different than the lodge one! The D17 forms are due February 15, 2018 and sent to the District President Andrew Johnsen.

## **Delegate totals and convention related documents are coming!**

I won't throw stones at the International as my "to-do" list in January is quite long and I have not gotten the delegate totals done. I hope to do that tonight after work. I still don't have the complete new officer listing so am still using the 2017 list but if the previous President or Secretary gets it, they need to forward it to the new ones.
