## District 5 Convention 2024 <br> HOW DO I BECOME A DELEGATE?

1. Be sure my dues are paid.
2. Check my calendar to be sure I am free from June 19-22, 2024.

3. When my lodge announces the date for election of delegates, I need to place my name on the list of candidates or ask someone to nominate me.
4. Let other members know I am interested and ask them to vote for me.
5. If elected, celebrate!
6. That's all there is to it!

## WHAT ABOUT ALTERNATES?

1. An alternate is elected for each delegate. In case the delegate is unable to fulfill their duty, the alternate fills in.
2. An alternate may be called upon at very short notice, but should be available if needed.*
3. An alternate may be elected to replace a specific delegate or be in line as first, second, third, etc order If needed.

It is very important to have alternates so a lodge is represented in case of an unexpected situation.
*If the registration fee has been paid, and a hotel reservation has been made, the registration would apply to the alternate; the delegate and alternate should make personal arrangements to transfer the hotel room to the alternate so they could have the group room rate.

Dear Sons of Norway District 5 Delegates,
Thank you again for serving as a delegate to the District 5 Lodge Meeting in Middleton, WI in June 2022. We have asked for your action previously on a bylaw proposal last year and now have the Task Force Recommendation for you to act on as we prepare for the 2024 District Lodge Meeting and Convention in Indianapolis, IN in June 2024.

As you have been kept informed over the past two years via emails, Friendly Fifth Friday News, our website section, and invitations to Task Force ZOOM meetings, we have looked at many different ways to restructure the District Board.

In September, we had the joint meeting of you (the delegates who served) and the Task Force. The group discussed the Task Force recommendation:

That the task force recommends the elimination of zones in District 5 and charges the board to consider various mechanisms for enhancing cohesion and communications between lodges and how we can serve lodge's needs. The new board structure would be President, Vice President, Secretary, Treasurer, Youth Director, Sports Director, Publicity Director, Cultural Director and four at-large Directors. All could serve two consecutive two-year terms with the exception of the District Secretary and Treasurer who would have unlimited terms. All positions would have an alternate elected for each position.

The board discussed this proposal at their fall board meeting and made one change in how the alternates would be. They made this change: A pool of 4 alternates for the 4 at-large directors shall also be elected.

I am enclosing the bylaw proposal which gives the current wording, changes, and how the new section would read. I also have a postcard that can be used as your ballot. Postcards should be returned by Saturday, January 20, 2024. At that time, we will have the board send the updated bylaws to International for acceptance and then the Nominating Committee will be able to proceed.

Par. 2 The President and Vice President shall be elected from separate Zones.

Par. 3. The President, Vice President, Secretary, Treasurer, Recreation Director, Publicity Director, Cultural Director and Youth Director shall be nominated and elected in that order, after which each Zone shall hold an election caucus and nominate the number of Directors and Alternates to which they are entitled as provided for in these By-Laws. These nominations shall be submitted to the District Lodge at the conclusion of the caucus.

Par. 4 All Zones shall be entitled to exactly (2) representatives on the Board. The Secretary and Treasurer shall not be counted as a representative against a Zone. An alternate for the Secretary and Treasurer shall also be elected. In the event of a vacancy or resignation, the Board can elect an officer who would be a third representative from a Zone but the said officer would not be a Zone Director.

Par. 5 A Presidential candidate shall have served on the District Board at least one full term.

Par. 6 No District Officer or Director shall be elected to serve more than two consecutive terms in any office except the Secretary and the Treasurer whose term shall not be limited. In the event a caucus cannot find a willing nominee to serve as a Zone Director and the current Zone Director has completed two consecutive terms, the Zone Director can complete a third term.

Par. 7 The President, Vice President, Secretary, Treasurer, Recreation Director, Publicity Director, Cultural Director, and Youth Director shall receive such compensation as determined by the District Lodge. The Board of Directors shall make recommendations to each District Lodge Meeting with respect thereto.

Par. 8 At the first meeting of the Board of Directors after a District Lodge Meeting, the Board shall determine the per diem and traveling expense allowance for members of the Board for the next biennium.

Par. 9 The President shall assign to each Officer and Director the lodges to be under his or her supervision.

Par. 10 At the opening of each District Lodge Meeting, the President shall appoint from the attending representatives a

Marshal and an Assistant Marshal and two greeters to serve during the meetings.

- Whereas the President invited over 70 members to serve on the Task Force representing the diversity asked for in the resolutions.
- Whereas the Task Force has been meeting via ZOOM, provided surveys, has a separate tab on the website to provide information, and had formed sub-committees to do in-depth discussion about the topics.
- Whereas the Task Force has also invited members of the District 5 Lodge on a call to discuss their proposal and came to a consensus that we should move forward with a bylaw proposal addressing the zones.
- Whereas the Task Force felt that other parts of our District Bylaws that refer to zones (for electing International delegates) can wait at this time and be handled by the 2024 delegates. They prefer to work on just the one part for now.

These nominations shall be submitted to the District Lodge at the conclusion of the eaucus.

Par. 4 All Zones shall be entitled to exactly (2) representatives on the Board. The Secretary and Treasurer shall not be counted as a representative against a Zone. An alternate for the Secretary and Treasurer shall be elected. In the event of a vacancy or resignation, the Board can elect an efficer who would be a third representative from a Zone but the said officer would not be a Zone Director. A pool of 4 alternates for the 4 at-large directors shall also be elected.
