Questions on the new Simplified Dues Structure

As we have read in the Viking and other Sons of Norway communications, the new Simplified Dues Structure will take place in January 2018. I am getting questions and concerns from lodges about details and I really don't know a lot more than what is being published and sent out.

Tomorrow International Jon Grinde is covering this topic at the Zone 3 meeting so I can share his comments next week. There is a tab on the International website that gives more information. We have some options for lodges who will see a dues increase- keeping the dues on the lodge level, refunding the difference, using the additional amount for a member benefit on the lodge level, and others.

Update on Sons of Norway's Simplified Dues Structure

Sons of Norway International delegates voted at the 2014 and 2016 International Lodge Meetings to proceed with a simplified dues structure for U.S. members only, effective January 1, 2018. The vote to implement the Simplified Dues Resolution sets the rule for the entire organization, and will put into effect the will of the International Lodge, your elected representatives.

We will continue to communicate with members about this change in dues structure as we get closer to the Jan. 1, 2018 implementation date.

2014 Resolution

Investigating and pursuing a simplified dues structure was voted on and approved by the delegates to the 2014 International Lodge Meeting. Delegates overwhelmingly supported the following resolution forwarded for consideration by District Five:

WHEREAS the current dues structure and membership categories are complicated and very hard to explain to prospective members AND for current members to understand; now,

THEREFORE BE IT RESOLVED that a committee be established by the International Lodge President to present a resolution in 2016 to the International Lodge which will simplify the current membership classifications to include Insurance/Social and Individual/Family and make total dues for each lodge consistent within each country.

2016 Resolution

In August 2016 at the International Lodge Meeting in Tacoma, a new dues structure was voted in by a strong delegate majority vote (121-32). This resolution applies to dues within the United States only.

Simplified Dues Resolution

WHEREAS the current dues structure and membership categories are complicated and very hard to explain to prospective members AND for current members to understand; and,

WHEREAS the 2014 meeting of the International Lodge passed a resolution for a committee to present a resolution in 2016 to simplify the current membership classifications to include Insurance/Social and Individual/Family and to make total dues for each lodge consistent within each country;

THEREFORE BE IT RESOLVED that the following law changes will be made to accommodate a more simple dues structure. As it states in the Constitution, the International Board of Directors will set dues annually at the Spring meeting. Effective January 1, 2018, the U.S. dues will be \$60 for an individual and \$95 for a family. The breakdown will be allotted as follows:

\$60 Individual Dues	INTERNATIONAL	\$32 (no change)

	LOCAL	\$14
\$95 FAMILY DUES	INTERNATIONAL	\$42 (reduction)
	DISTRICT	\$25
	LOCAL	\$28

Q & A

Will the dues still be discounted for central lodge members with an insurance product? **Yes.**

Do current Golden and Life members lose their special dues rates? No. Life members will continue to be free; Golden members who qualify before 2018 will retain their reduced rates. Rates for Golden members will be set by the International Board at their spring 2017 meeting.

Do Unge Venner need to share an address with a family member to be free? **Yes.**

Do Heritage members need to share an address with a family member to be free? *Heritage members are always free.*

How were the dues changes determined?

The dues figures were settled on after reviewing the full range of amounts paid across the organization. The goal was to ensure that this change would not financially penalize lodges.

If a lodge doesn't need to collect the \$14 local fee, may it be refunded to members? *Those lodges that have little to no dues at present may use the additional funds to increase programing, charitable giving and/or community support, or they may refund the dues income to their members.*

How will the simplified dues structure be of benefit to members? Simplifying the dues structure to maintain consistency throughout the U.S. has been a discussion point for years. With the new plan in place, more time will be freed up for sons of Norway staff to better serve our members.
