#### **Barnebirkie Report**

Darlene Arneson gave a presentation on the TUBFRIM program.

Lucy Ghastin have an update on convention activities including today's bus tour for non-delegates, Sangerfest activities, and music tonight. She encouraged members to visit the vendors, enjoy the displays, the H.R. Holand sales table, and Owen & Elspeth will give a re-enactment at 7 PM in the Greenway Room.

Robin Fossum and the Nominating Committee presented their initial report. The committee included Chair Robin Fossum, Tom Boudreau, and Andrew Johnsen from the District Board.

In Spring of 2021, Sons of Norway International Board President Ron Stubbing appointed the International Nominating Committee: Gloria Benazic (D7), Ken Johnson (D3), and Jon Tehven (D1) as chair. Chair Tehven contacted all District Presidents to appoint their District Nominating Committees.

When the District Nominating Committees were established, the International Nominating and the District Nominating Committee chairs began monthly zoom meetings. The first meeting was in July 2021. We would like to thank and complement our treasurer Duane Kittleson on his reports and willingness to step in.

The committee reviewed the financial reports on pages 40-49 of the Reports Book and note the following:

- The amount of \$950 is missing on page 41 for "Website Expenses" but the totals at the bottom of the columns are correct.
- No budget has been presented or approved for the last six years but a budget for FY 2022 has been presented to the Board by the Treasurer. This budget has not yet been discussed or approved.
- The new dues structure has allowed the District to have better financial health and the District 5 Nordic Legacy Foundation allows for a more robust financial structure for Mase Morro.

The Finance committee met over Zoom prior to meeting in person and have discussed potential positions descriptions and responsibilities which we can make available to the Board for their consideration. We further suggest the Board appoint a finance committee after the convention to assist the Treasurer in working with the CPA firm and the Board. Due to the substantial expense in utilizing the CPA firm we recommend that the Board develop a plan to reduce the CPA firm's involvement to where they are only assisting with the preparation of governmental reporting.

#### **Governance and Fraternal Changes Presentation**

Connie O'Brien, Director of Fraternal & Foundation Development, gave a presentation on the changes in governance for Sons of Norway, changes in the Fraternal Department and programs, and other updates from the home office.

"The business funds the mission" was the theme of her speech as she explained rapid growth of Insurance Professionals (IP's), premium growth, and sales the past three years. We are regulated by the Minnesota Department of Commerce. She explained the governance structure from a Convention/Assembly structure to a Direct Election/Board structure. It was filed with the Minnesota Department of Commerce on October 29, 2021 and deemed effective on January 6, 2022.

The new Charter, Bylaws, Policies and Procedures were filed on June 6, 2022, and should be effective on August 6, 2022. Connie reviewed the key changes in the governance program.

Treasurer Duane Kittleson announced the Heads n Tails fundraiser raised \$285 at the noon luncheon.

Connie's second presentation was on the Fraternal programs including an update on the 2022 International Convention and Lodge Meeting which will be virtual on August 31-September 1. She also covered changes in the Viking Magazine, Viking for Kids, internal supply to an outside vendor, new volunteer pins, leadership videos, and Lodge Resource email that has an open rate of 80% which is far above industry averages. The new website Lodge Directory should be relaunched in June with a new format. Connie also reviewed digital content, membership recruitment, and social media outreach.

The proposal passed with a 2/3 vote.

Each year, Sons of Norway lodges who score high points on their Lodge Achievement Forms are awarded a Merit Certificate. These Gold, Silver and Bronze awards are based on their total Lodge Achievement scores. They are presented at the biennial District Conventions.

The highest score a lodge can achieve is 100 points. In 2018 and 2019, lodges scoring 80 points or higher earned a Gold Merit Award, lodges scoring 65 to 79 received Silver and lodges hitting 50 to 64 points were awarded Bronze. The thresholds for 2020 and 2021 were adjusted due to the pandemic. In 2020 and 2021, lodges needed to score 65 or more to be Golden, 50 to 64 to be Silver and 35 to 49 for Bronze.

# **RESOLUTION #1 VIKING HELMET INACCURACIES.**

Title of Resolution: Viking Helmet Inaccuracies.

WHEREAS, the Sons of Norway mission is to promote and preserve the heritage and culture of Norway and some lodges are promoting an inaccuracy by members wearing "Viking Helmets with horns" in parades, dramatic presentations, and pictures; and

WHEREAS, Elizabeth Nix, an Associate Professor of history at the University of Baltimore wrote for <u>history.com</u> that historic "depictions of people from the Viking era show warriors either bareheaded or in simple leather or iron helmets" and the only complete helmet from the Viking era excavated in an archaeological dig (Gjermuindbu farm) has a rounded or slightly peaked cap made of four iron plates, a guard around the eyes and nose and no horns; and

WHEREAS, the stereotypical helmet with horns started showing up after the costume designer Carl Emil Doepler, used it in clothing Viking characters in the 1870's Wagner mythical opera series "Der Ring des Nibelungen;"

THEREFORE, be it resolved that District 5 Sons of Norway members will discontinue the wearing of helmets with horns in all Lodge activities to stop the promotion of something that is inaccurate.

COMMITTEE RECOMMENDATION: Recommendation to Reject

# **REASONING:**

1. Even though the use of horned helmets is known to not be historically accurate it is believed that members and non- members do associate horned helmets with Vikings or Nordic characters.

2. There are no provisions of penalty for the use of horned helmets at any Lodge events.

3. Policing or enforcing any use of horned helmets at events would be difficult to enforce. And may actually deter individuals or families from learning more about Norwegian culture.

The committee's motion to reject resolution 1 was approved. The resolution failed.

The Fraternal Affairs Committee met and had a wide-ranging discussion on a variety of topics, which included:

# Sons of Norway Cultural Skills and Sports Medals.

There were good marks for these programs. Many lodges participated in different activities, but most reported the best success with group activities, cooking classes, language classes, and working in groups. As with so many things, leadership and motivation were key and doing things together helped in this regard. Some of the programs proceeded virtually, especially successful were "virtual walks" using a "Passport" to record virtual destinations that were visited.

#### Masse Moro and Barnebirkie

Two 5<sup>th</sup> District signature cultural events are the Masse Moro Camp for young people and the Barnebirkie cross country ski race. Both programs continue and are well received and supported by local lodges. However, the cost of the camp continues to increase and many lodges offer scholarships for

youth to attend. More details about these programs are available elsewhere so the committee's focus was on how local lodges responded and interacted.

# Response to Covid, You can't stop a Norwegian

Local Lodges, the District and International used Zoom and other online resources to keep members connected through the pandemic. Virtual 17<sup>th</sup> of May celebrations, online seminars, conducting board meetings and business sessions via Zoom, Nordic News Radio and other programs kept the Norwegian Spirit going through the shut downs, quarantines, closures, mask mandates and other obstacles the virus created. Some lodges moved outdoors and replaced meetings with socially distanced picnics and other outdoor events. On the other hand, programs on Zoom allowed experts with specific knowledge to share their expertise with a broader audience that would be impossible at dozens of individual lodge meetings. For example, a Zoom presentation on Immigration incorporated experts from various areas who could never all appear at one lodge meeting in person. Several groups had virtual book clubs that kept members involved.

# **Viking Magazine**

The new Viking Magazine format did not receive a favorable review. Eliminating the District Photo page was not well received and there was some discussion that the layout and type stye and size made the magazine more difficult to read. Some of the reasons for the changes were explained which included trying to create a more national focus, reduce the number of old people drinking coffee pictures (that is the author's characterization, not Sons of Norway International's description) and that some districts did not provide relevant photos consistently. Maybe a page focusing on a different district each issue, rotating through the districts, would satisfy everyone's concerns.

# **New Programs and Ideas**

One intriguing program discussed was the members of one lodge who bring a program into the schools dealing with immigration and local history. They work with the local social studies teachers and present sections on immigration. Less extensive programs dealing with immigration, Vikings, the westward expansion and life on the prairie or dozens of other topics could be developed and offered to local schools if the talent and interest was available. There was also a suggestion Sons of Norway establish a running or jogging sports medal to specifically recognize accomplishments in that sport. It is always stunning to see the energy, passion and expertise displayed by our members. Knowledge of Norwegian children's songs, language learning games and devices and other cultural expressions and customs were all discussed and can now be developed and shared online in ways that never could before.
